Working Groups

APSN features five working groups that meet annually.

WG-1 Safeguards Infrastructure Implementation and Awareness

Coordinates APSN programs and activities in infrastructure, implementation, awareness, and research and development collaboration.

WG-2 Capacity Building

Supports members with safeguards capacity building by identifying needs and exchanging information.

WG-3 IT Support, Communication, and Information

Maintains the APSN website, examines relevant information technology issues, and develops APSN communication and outreach.

WG-4 Experiences in Safeguards Application

Provides references and experience sharing on safeguards regulatory framework as well as topical issues such as safeguards by design.

WG-5 Physical Protection in Support of Nuclear Safeguards

Examines physical protection matters in support of national safeguards activities and the interface between safeguards and other domains.



Why do Safeguards Matter?

Nuclear energy has the potential to contribute to health and prosperity throughout the world. However, it may also be used for the development of nuclear weapons. The implementation of IAEA safeguards, therefore, serves as an important confidence building measure, through which a State can demonstrate – and other States can be assured – that nuclear material is being used only for peaceful purposes. Practically all countries around the world use nuclear applications for a variety of peaceful purposes, including food and water security, energy, industrial applications, and human health.

The Asia-Pacific region includes some of the world's most rapidly developing economies. Through APSN, many of these countries have committed to innovation in nuclear technologies to improve quality of life and enhance economic development. APSN hopes to share its vision and experience to contribute to a healthier and more prosperous world. APSN creates a mechanism for government officials and regulatory practitioners to exchange information, share good practices, and help one another.

About the Asia-Pacific Safeguards Network

In 2008, officials with safeguards responsibility in Australia, Indonesia, Japan, and Republic of Korea had a vision for creating a forum for nuclear safeguards practitioners in the Asia-Pacific to collaborate and learn from one another.

In 2009, the Asia-Pacific Safeguards Network, or APSN, was formed and has since evolved into a professional organization in the Asia-Pacific to facilitate the exchange of safeguards information, knowledge, and practical experience to strengthen safeguards capabilities in the region.

Over the past decade, APSN has helped its members improve the quality, effectiveness, and efficiency of safeguards implementation by:

- Supporting sustainable national nuclear safeguards capabilities
- Promoting regional cooperation in nuclear safeguards applications and sharing good practices
- Facilitating the coordination and provision of nuclear safeguards technical assistance
- Providing a forum for knowledge sharing
- Developing a region-wide network of national nuclear safeguards practitioners

APSN had its origins in discussions with my Indonesian, Japanese, and Korean colleagues in the early 2000s. We saw the importance of regional collaboration in strengthening safeguards, particularly through experience sharing, promoting safeguards culture and capacity building. 


